#### MAHARASHTRA ACT NO. XXXI OF 1982

(First published, after having received the assent of the President in the "Maharashtra Government Gazettee" on the 14th October, 1982)

An Act to provide for preventing malpractices at University. Board and other specified examinations.

WHEREAS, both House of the State Legislature were not in session ;

AND WHEREAS the Governor of Maharashira was satisfied that circumstance existed which rendered it necessary for him to take immediate action to have a special law in this State to provide for preventing maloragenees at examinations held or proposed to be held by any University or the Mand or any other authority specified by the State Government in this behalf, including leakages of question papers or copying at such examinations, and for matters connected therewith, and, therefore, promulgated the Maharashira Prevention of Malpractices at University, Board or other specified Examinations Ordinance, 1982, on the 25th May 1982;

- (e) "Possession of unfeir means material by a student' means having any unauthorised material on his/ har person or deak or chair or table or at any place within his/her reach, in the examination centre and its environs or premises at any time from the commencement of the examination till its conclusion...
- "Student found in possession" means a student, reported in writing, as having been found in possession of untair means material by Jr. Supervisor, Sr. Supervisor, member of the vigilance Committee or Examination Squed or any other person authorised for this purpose, in this behalf, even if the unfair means material is not produced as avidence because of it being reported as swallowed or destroyed or snatched away or otherwise taken away or spolled by the student or by any other person acting on his behalf to euch an extent that it has become likegible. 

- (iii) The concerned person be asked to appear before the Inquiry Committee on a day, time and place fixed for meeting, with written reply/explanation to the show cause notice served on him/ her and charge levelled against him/her therein. The concerned person himself/heread only shall present hig/her case before the Committee.
- (iv) The documents that are being taken into consideration or to be relied upon for the purpose of proving charge/s against the concerned person shall be shown to him/her by the inquiry Committee if he/she presents himself/herself before the committee. The evidence, if any should be recorded in presence of the delinquent.
- (v) Reasonable opportunity, including oral hearing, shall be given to the concerence person in his/ her defence before the Committee. The reply/explanation given to the show cause notice shall also be considered by the Committee before making final report/recommandation.
- (vi) The Committee should follow the above procedure in the spirit of principle of natural justice.

- (i) Declaring disqualified the concerned paper-setter, examiner, moderator, referee, teacher or any other parton connected with the conduct of examination, from any examination work either permanently or for a specified period.
- (ii) imposing line. If the concerned person fails to pay the fine within a stipulated period, the Competent Authority may impose on such a person additional punishment/penalty as it may down fit.
- (iii) Refaming his/her case to the concerned disciplinary authorities for taking such disciplinary action as desired fit as per the rules governing his/her service conditions.
- (iv) The computent authority or the Officer sufficient in this behalf, shall inform the concerned person of this decision taken in his/her case and the punishments imposed on him/her.
- (v) An appeal made within 30 days of imposition of the punishment, other than the punishment referred to in clause No. (III) above, shall lie with the Board of Examinations if the case is pertaining to the University examination or with the Management of the College or Institution, if the case purishing to the collegeInstitutions examination and their decision in the appeal shall be deviated and indicated. be final and binding.
- (vi) The Competent Autholnity shall supply a typed copy of the relevant extract of fact-finding report of the Inquiry Committee, as well as the documents relied upon (if not strictly confidential), perielining to flicther case to the appellant/petitioner, if applied for in writing.
